First Quarter 2024




A quarterly bulletin issued by Ras Al Khaimah Center for Statistics, contains foreign trade data received from the Customs Department in Ras Al Khaimah, which includes trade movement data made through the emirate's ports.

## Introduction

Foreign trade Statistics are important statistics, they enable the production of a wide group of statistical indicators that show movement of goods that entered or exited from emirates ports (Marine, land, and air). The department of customs in Ras Al Khaimah is the main source of the data, as it monitors the trade movement through 12 custom centers in the emirate.

The data in the report, covers all the trade movement through the emirate's ports to the outside world; it does not include trade transactions of Ras Al Khaimah done through the ports in other emirates.

The center has adopted the general trade system in producing trade data based on international recommendations to adopt this system to produce the data.

The center extends its sincere thanks to the customs department in Ras Al Khaimah for its full collaboration with the center in providing the data to produce the foreign trade statistics.



- "-" = The value equals zero.


#### **Concepts and Terminology**

- The economic territory: is the area under the effective economic control of a single Government in which it gets things done effectively.
- The General trade system and the Special trade system: The general trade system is in use when the statistical territory in a country coincides with the economic territory. While the special trade system is in use when the statistical territory comprises only a particular part of the economic territory.

## Special trade system






## **Trade Balance & Imports**

#### Trade Balance

The trade balance has a surplus of 2,398 million dirhams in the first quarter of 2024, decreasing by 3% in comparison with the fourth quarter of 2023, and has increased by 121% in comparison with the same quarter of the previous year.




#### **Imports**

The total imports were 2,186 million dirhams in the first quarter in the 2024 comparing it with 2,377 million dirhams in the fourth quarter of 2023, decreasing by 8%, and comparing it with the same quarter of the previous year, the data showed that the decreasing was approximately 21%.

As for the country of origin, 17% of the imports were from China, 14% from India and 9% from United States.

As for the types of the imported goods, the data showed that the imports of foodstuffs, beverages, spirits and tobacco products were in the first place with a value of around 547 million dirhams, followed by the machinery and mechanical appliances, electrical equipment with 376 million dirhams and mineral products 343 million dirhams.

#### Imports By Type of Commodity - Q1-2024




## **Exports**


In comparison with the fourth quarter of 2023, exports decreased by 3% in the first quarter of 2024 and reached around 3,807 million dirhams in the first quarter 2024. By comparing it with the first quarter of the previous year (2023), it increased by 20% where the total exports were 3,161 million dirhams.

The data showed that most of the exports were in the foodstuffs, beverages, spirits and tobacco products, the exports of this group were around 2,102 million dirhams, followed by mineral products with 1,026 million dirhams.

Based on the destination, exports to India were 13% in the first quarter of the year, exports to Oman were 13%, and exports to Iraq were 11% of total exports.



Exports By Main Trade Partner - Q1- 2024




## **Re-exports**

In the first quarter of 2024, the total of re-exports were around 777 million dirhams, decreasing by 15% in comparison with the previous quarter (Q4 - 2023). By comparing it with the first quarter of the previous year, data shows that there is an increase in re-exports by 14%.

The data showed that re-exports of machinery and mechanical appliances, electrical equipment were 175 million dirhams and of vehicles of transport were around 142 million dirhams.

Based on the trade partner out of total re-exports, the re-exports to Oman were 54%, to Malaysia 8%, and to Iraq 6%.
