Fourth Quarter 2023




A quarterly bulletin issued by Ras Al Khaimah Center for Statistics, contains foreign trade data received from the Customs Department in Ras Al Khaimah, which includes trade movement data made through the emirate's ports.

## Introduction

Foreign trade Statistics are important statistics, they enable the production of a wide group of statistical indicators that show movement of goods that entered or exited from emirates ports (Marine, land, and air). The department of customs in Ras Al Khaimah is the main source of the data, as it monitors the trade movement through 12 custom centers in the emirate.

The data in the report, covers all the trade movement through the emirate's ports to the outside world; it does not include trade transactions of Ras Al Khaimah done through the ports in other emirates.

The center has adopted the general trade system in producing trade data based on international recommendations to adopt this system to produce the data.

The center extends its sincere thanks to the customs department in Ras Al Khaimah for its full collaboration with the center in providing the data to produce the foreign trade statistics.



  - "-" = The value equals zero.


#### **Concepts and Terminology**

- The economic territory: is the area under the effective economic control of a single Government in which it gets things done effectively.
- The General trade system and the Special trade system: The general trade system is in use when the statistical territory in a country coincides with the economic territory. While the special trade system is in use when the statistical territory comprises only a particular part of the economic territory.

# **Trade Balance & Imports**

#### Trade Balance

The trade balance has a surplus of 2477 million dirhams in the fourth quarter of 2023, increasing by 26% in comparison with the third quarter of 2023, and has increased by 65% in comparison with the same quarter of the previous year.




#### **Imports**

The total imports were 2376 million dirhams in the fourth quarter of 2023 comparing it with 2241 million dirhams in the third quarter of 2023, increasing by 6%, and comparing it with the same quarter of the previous year, the data showed that the increase was approximately 27%.

As for the country of origin, 20% of the imports were from China, 10% from India, and 7% from United States.

As for the types of the imported goods, the data showed that the imports of foodstuffs ,beverages, spirits and tobacco products were in the first place with a value of around 596 million dirhams, followed by the machinery and mechanical appliances, electrical equipment with 363 million dirhams and mineral products 314 million dirhams.

#### Imports By Type of Commodity - Q4-2023






# **Exports**


In comparison with the third quarter of 2023, exports increased by 10% in the fourth quarter of 2023 and reached around 3934 million dirhams in the fourth quarter of 2023. By comparing it with the fourth quarter of the previous year (2022), it increased by 44%, where the total exports were 2731 million dirhams.

The data showed that most of the exports were in foodstuffs, beverages, spirits, and tobacco products. The exports of this group were around 2234 million dirhams, followed by mineral products with 1040 million dirhams.

Based on the destination, exports to Oman were 12% in the fourth quarter of the year, exports to India were 12%, and exports to Iraq were 12% of total exports.



Exports By Main Trade Partner - Q4- 2023






# **Re-exports**

In the fourth quarter of 2023, the total of re-exports was around 919 million dirhams, increasing by 46% in comparison with the previous quarter (Q3-2023). By comparing it with the third quarter of the previous year, the data shows that there is an increase in re-exports of 43%. The data showed that re-exports of vehicles of transport were 315 million dirhams, and of machinery and mechanical appliances, electrical equipment were around 178 million dirhams. Based on the trade partner out of total re-exports, the re-exports to Oman were 44%, to Guinea 6%, and to Malaysia 6%.

- **Data source:** data of customs transactions from the Customs Department in Ras Al Khaimah.
- Methodology of the data production: The data was produced based on the General System of Foreign Trade.
- Coverage: The data contains all the transactions of importing, exporting, and re-exporting, done through the customs ports of Ras Al Khaimah, therefore, the data in this report does not include the foreign trade data of the emirate of Ras Al Khaimah done through other emirates.
